ACCORDING TO THE INFORMATION OBTAINED THE FOLLOWING OCCURRED. WHILE UNLOADING AT THE ROADWAY EXPRESS, INC. TERMINAL, A LEAK WAS DISCOVERED IN THE TRAILER. APPARENTLY THE RELEASE OCCURRED DUE TO IMPROPER LOADING. ONE CARDBOARD CARTON WAS DISCOVERED DAMAGED. ONE (1) 1-GALLON PLASTIC JUG WAS DAMAGED INSIDE THE CARTON, RELEASING APPROXIMATELY 4 OUNCES OF FREE PRODUCT. TERMINAL PERSONNEL PERFORMED THE CLEANUP USING LEVEL D PPE AND ABSORBENT MATERIAL. ABSORBENT MATERIAL, PPE, AND CONTAMINATED DUNNAGE WERE PLACED INTO ONE (1) 35-GALLON FIBER RECOVERY DRUM. THE DAMAGED CONTAINER WAS PLACED INTO ONE (1) 10-GALLON FIBER RECOVERY DRUM. BOTH DRUMS WILL BE HELD FOR DISPOSITION. THERE WERE NO INJURIES OR EXPOSURES REPORTED. MSDS WAS REQUESTED AND RECEIVED.
