Describe:

During transit a passing motorist indicated to our driver that there was a problem with his load. He was able to pull over safely off the side of the road and discovered that an IBC had developed a vertical crack in the body and was leaking the tote contents. The crack which developed was approximately 1.5-2 feet in length. The driver called in the incident to corporate management and Highway Patrol arrived on the scene. An emergency response company was called to clean up the spilled material. The material (sodium hydroxide solution) was on the dirt shoulder of the road and did not enter any other medium. Traffic was controlled on several lanes of the Highway to allow for safe cleanup of the material. Cal Trans was called onto the scene by the Highway Patrol. Material was cleaned up to the satisfaction of Cal Trans. There were no injuries or additional incidents.
