DRIVER HAD FINISHED LOADING HIS TRUCK FROM THE TANK CAR AND COULD NOT GET THE VALVE OR VALVE PLUG TO SEAL. DRIVER WAS AFRAID TO TIGHTEN PLUG TO TIGHT; THOUGHT VALVE MAY HAVE BEEN CRACKED. INITIALLY IT SEEMED THE MORE HE TIGHTENED IT, THE MORE IT LEAKED. AFTER 5 1/2 HOURS, OUTSIDE HEL ARRIVED AND PLUG WAS TIGHTENED AND LEAKAGE STOPPED. 3P CHEMICAL WILL DETERMINE WHY VALVE DIDN'T SHUT OFF. REPORTED TO NRC REPORT 149657.
