Driver responsible for loading product at customer site failed to appropriately monitor loading process and overfilled cargo tank resulting in approximately 150 gallon spill of molten sulfur. Plant personnel who noticed the spill took action and loading process was stopped. Spill was contained and cleaned up by plant personnel. There was no equipment/mechanical failure that contributed to this event. The cause of the spill was human error as the driver failed to monitor the process as required.
