DRIVER TURNED VALVES OFF TO ISOLATE THE PROPANE LEAK BEFORE EXITING THE VEHICLE. THE RELEASE OCCURRED DUE TO A FITTING THAT WAS BROKEN ON THE LIQUID LINE UNDER THE METER. ROAD WAS CLOSED FROM APPROXIMATELY 9:30AM TO 2:30PM. 6 HOMES WERE EVACUATED AS A PRECAUTION.
