OPERATOR MISS ALIGNED VALVE, WHICH RESULTED IN THE RELEASE. AN UNKNOWN AMOUNT OF SULFURIC ACID WAS RELEASED TO THE GROUND. ESTIMATED QUANTITY OF THE RELEASE WAS GREATER THAN 1,000 LBS. BUT LESS THAN 25,000 LBS. THE RELEASE REMAINED ENTIRELY WITHIN THE PDMI FACILITY BOUNDARY. IN RESPONSE TO THE RELEASE, THE VALVE WAS SHUT OFF, WHICH STOPPED THE RELEASE. THE SOIL CONTAMINATED WITH THE SULFURIC ACID WAS EXCAVATED AND ADDED TO THE PROCESS BY PLACEMENT ONTO A LEACH STOCKPILE FOR RECOVERY OF ACID VALUES. NO MEDICAL ATTENTION WAS REQUIRED FOR THE OPERATOR. SULFURIC ACID LOADING PROCEDURES ARE BEING REVIEWED WITH FACILITY PERSONNEL AND OPERATORS.
