WHEN HE MADE THE RIGHT TURN ONTO ANTELOPE ROAD THE TRACTOR AND TRAILER OVERTURNED ONTO THE GUADRAIL. THE POSTS SUPPORTING THE GUARDRAIL PUNCTURED THE TANK IN 2 PLACES CAUSING PRODUCT TO SPILL ONTO THE GROUND. DRIVER WAS GOING TO FAST AROUND THE TURN CAUSING OVERTURN. HE WAS DISCARDED FOR CAUSING THE OVERTURN. THE CONTAMINATED SOIL IS BEING EXCAVATED AND DISPOSED OF AT A LANDFILL. FRESH SOIL WILL BE BACK FILLED INTO THE AREA.
