Describe:

ADMX 30052 and ADMX 29696 were involved in a derailment resulting in loss of product from both cars as follows:

ADMX 30052, tank head puncture, lost approximately 15,000 gallons, most consumed by fire. The remaining approximately 13,000 gallons left in the tank was transferred to trucks for further handling.

ADMX 29696, derailed and came to rest on it's side. Approximately 1,000 gallons of material leaked from the vapor line due to a loose cap. The remaining material will be transferred to another rail car.

This incident was in a remote area, no evacuation. One county road was closed to thru traffic for about 20 hours but remained open to local and emergency traffic.
