Pilot vehicle sideswiped disabled vehicle on roadway shoulder. Pilot vehicle went into ditch and rolled thus rupturing the cargo tank at the number 1 compartment releasing approximately 2800 gallons of diesel fuel. Our ER contractor arrived to mitigate diesel fuel loss and begin clean up.
