Describe:

Truck and trailer loaded with 7900 gallons of Ethanol was E/B on US Hwy. 20 in the rain traveling at approximately 45 mph. A car came up on his left side and entered the spray from his tires. The car started to lose control and drifted to the right forcing the truck to move to the right to avoid a collision. The truck drifted too far off the shoulder and drove down the embankment. The driver attempted to drive the truck back onto the road but over-corrected and the truck and trailer rolled onto its right side, then rolled completely over coming to rest on its left side against an electrical pole. The driver climbed out of the cab and called 911. Though the tank suffered multiple dents there was no breach from the shell. A dome cover had a minor drip which lasted approximately 4 to 5 hours until the Emergency Response Contractor arrived at the scene. They placed a spill pad under the drip to absorb the product until the tank could be tapped and pumped out. Illinois EPA was on scene and said there was no environmental impact from the Ethanol.
