Describe:

Driver was eastbound on 300th street coming into a S curve on 290th Ave. Driver lost control causing the truck to overturn and enter the north ditch. The Vehicle continued over 290th Ave, the tractor separated from the tanker and came to a rest east of 290th Ave. Vehicle was pulling Anhydrous Ammonia and the accident caused the tanker to rupture. The driver was extracted from the truck and taken to Spencer Hospital. The release was several minutes, the tank ruptured on the left front bulkhead, about 2-4 inches. The release stopped due to auto-refrigeration, and when was safe, the remaining product was pumped off on to another trailer.
