Describe:

During dock operations, a reported forklift accident resulted in the release of approximately 150 gallons of a UN1824 Sodium Hydroxide Solution to the rear of a trailer, adjacent concrete dock floor and adjacent concrete and asphalt parking lot. No drains, soils or waterways were impacted by this release. An environmental contractor was dispatched and transferred the remainder of the product from the damaged tote into a replacement tote. Soda Ash was applied to the impacted areas. All wastes were collected, containerized and staged on site for pending disposal. The tote was tote was also staged on site pending the shipper's disposition.
