UNIT WAS TRAVELLING SOUTH ON US 89 APPROX 1/2 MILE FROM JUNCTION I-15 & US- 89. 3 DEER CAME FROM DITCH AND RAN ACROSS HIGHWAY. THE FORWARD MOMENTUM MOV ED THE TRACTOR TOWARD THE CENTER WHILE CAUSING THE BACK PUP TO SLIDE TO THE EAST. THE SWAYING MOTION CAUSED THE BACK TRAILER TO GO TO THE EAST SIDE OF THE HIGHWAY CATCHING THE ASPHALT. THIS CAUSED THE TRAILER TO SLIDE SIDEWAY S AND THEN LAY ON ITS LEFT SIDE. THE TRAILER SLID APPROX 100 FT DOWN THE CE NTER OF THE HIGHWAY. THE SLIDING ACTION CAUSED A SMALL HOLE IN THE TANK REL EASING APPROX 600 GALLONS LIGHT OIL.
