ON FEBRUARY 9, 1994 AT 12:15 PM A GATEWAY WESTERN TRAINMAN DISCOVERED GATX 99533, CAR OF ISOPROPYL ACETATE, ON TRACK #29 B- YARD IN EAST ST. LOUIS LEAKING AT THE BOTTOM OF OUTLET. A CALL WAS PLACED TO THE CONSIGNEE, TRANS. CHEMICAL IN ST. LOUIS, MISSOURI AND THE CAR WAS MOVE TO THE GATEWAY WESTERN "OLD PIG RAMP" AS A PRECAUTION. TRANS CHEMICAL SENT FOUR TANKER TRUCKS FOR LOAD TRANSFER AND ON ARRIVAL ONE OF THE DRIVERS WENT TO THE DOME OF THE CAR AND TIGHTENED THE VALVE AND THE LEAK STOPPED. CAR WAS RELEASED TO FISCAL DESTINATION. ACCORDING TO THE CONSIGNEE, APPROXIMATELY 340 GALLONS OF THE COMMODITY LEAKED FROM THE CAR AND THAT CLEAN-UP WOULD NOT BE NECESSARY DUE TO THE RAPID EVAPORATION OF THE COMMODITY.
