Describe:

Our driver attempted to avoid a rear end collision which resulted in the cargo tank trailer initiating a jack knife. The left side of the cargo tank collided with the rear right corner of a cargo van trailer. This resulted in a rupture of the cargo tank shell. Approximately 6000 gallons of product was released from the cargo tank. Approximately 600 gallons of the product entered a storm drain system exiting into Hogans Creek. Spill booms and pads were deployed to contain the product. The remaining product collected in a open swell ditch. A vacuum truck was used to recover all free product.

Our emergency response contractor worked to mitigate further impact to the environment at the time of the release. Extensive remediation activities commenced the following day with the oversight of the Florida Department of Environmental Protection and the city of Jacksonville Environmental Department.
