OUR TRUCK WAS TRAVELING ON A TWO LANE ROAD, WHEN THE DRIVER WAS FORCED INTO A FARM DRIVEWAY BY TWO ONCOMING CARS. HE FAILED TO MAKE THE TURN AND THE TRACTOR/TRAILER TURNED OVER ON ITS RIGHT SIDE. THE DRIVER MADE CONTACT WITH THE DUNKERTON, IA FIRE DEPT, AND THEY, ALONG WITH BLACKHAWK COUNTY SHERIFF'S DEPT, RESPONDED IMMEDIATELY. UPON ARRIVAL THEY FOUND THAT OUR LOADED TRAILER WAS INTACT EXCEPT FOR SOME PIPING AND VALVES THAT HAD BROKEN UPON IMPACT WITH THE GROUND. THEY THEN PROCEEDED TO OFF-LOAD THE PRODUCT ONTO ANOTHER TRAILER, TO AVOID ANY FURTHER SPILLAGE THAT MAY HAVE OCCURRED IN THE PROCESS OF PULLING THE RIG OUT OF THE DITCH. AT FIRST, THE SPILL SEEMED TO VERY MINIMAL, BUT WHEN THE GREATER LOSS WAS DETECTED AT THE CONSIGNEES DESTINATION, THE DNR WERE CALLED IN TO ACCESS THE SITUATION AND GIVE THEIR RECOMMENDATIONS FOR CLEAN UP.
