DRIVER ARRIVED AT CUSTOMER BULK PLANT AND HOOKED UP UNLOADING LINES TO CUSTOMER TANK PER HIS INSTRUCTION AND PROCEEDED TO UNLOAD. DURING THE COURSE OF UNLOADING, AN EMPLOYEE OF THE BUSINESS NOTICED PRODUCT OVERFLOWING FROM THE TOP OF UG STORAGE TANK AND ALERTED THE DRIVER ABOUT THE PROBLEM. THE DRIVER STOPPED THE FLOW OF PRODUCT INTO THE TANK AND THE OVERFLOW PRODUCT WAS CONTAINED IN THE CONCRETE CONTAINMENT AREA. THE DRIVER REPORTED THE INCIDENT TO DISPATCH OFFICE AND MONITORED THE SITUATION AT THE BULK PLANT. AFTER A PERIOD OF ABOUT 45-60 MINUTES, THE PRODUCT IN THE CONTAINMENT AREA LEAKED OUT ALONG THE SIDES OF THE CONCRETE WALL. THIS INCIDENT WAS REPORTED TO THE NRC, SERC AND LOCAL DEQ. REMEDIATION OF THE SITE STARTED IMMEDIATELY AND THE CONTAMINATED SOILS WERE REMOVED. UNDER THE GUIDANCE OF THE LOCAL DEQ AND AN ENVIRONMENTAL FIRM, RESIDUALS MANAGEMENT INC (RMI)- BOISE, ID, THE SITE HAS BEEN FULLY REMEDIATED AND BACKFILLED. THIS LOCATION HAD 2 TANKS ON THE SAME MANIFOLDED PRODUCT LINE. THE DRIVER HAD NEGLECTED TO SWITCH A QUARTER TURN VALVE TO THE PROPER TANK PRIOR TO STARTING THE UNLOADING PROCESS. SUBSEQUENTLY, THE #2 DIESEL HE WAS UNLOADING WENT INTO THE #1 DIESEL TANK WHICH RESULTED IN THE TANK OVERFLOWING THROUGH THE TOP VENT. SINCE THE INCIDENT, THE DRIVER HAS BEEN REPRIMANDED FOR NOT FOLLOWING PROCEDURES THAT WOULD HAVE PREVENTED THIS INCIDENT
