THE DRIVER WAS HEADING NORTH ON INTERSTATE 29 WHEN HE ENCOUNTERED A PATCH OF ICE. THE DRIVER LOST CONTROL OF THE VEHICLE, THE VEHICLE OVERTURNED SEVERAL TIMES IN THE MEDIAN BEFORE COMING TO REST IN THE MEDIAN. LIQUID ARGON PRODUCT WAS RELEASED FROM THE SEVERED VALVE, LOCATED AT THE REAR OF THE TANK. THE DRIVER GOT OUT OF THE VEHICLE, RECEIVED ASSISTANCE FROM OTHERS WHO HAD STOPPED. THE ELK POINT VOLUNTEER FIRE DEPARTMENT WAS SUMMONED. I-29 TRAFFIC WAS STOPPED FROM BOTH DIRECTIONS DUE TO THE RELEASE OF LIQUID ARGON WHICH IMMEDIATELY VAPORIZED TO ARGON GAS. ONCE EMERGENCY PERSONNEL WERE MADE AWARE THAT ARGON GAS IS AN INERT GAS, TRAFFIC WAS ALLOWED TO CONTINUE. THE APPROXIMATE AMOUNT OF TIME THE INTERSTATE WAS CLOSED WAS 1.5 HOURS. THE VEHICLE DAMAGED WAS A 1995 INTERNATIONAL TRUCK, VIN 1HTSDAANXSH651799.
