DRIVER WAS UNLOADING INTO AN ABOVE GROUND STORAGE TANK, USING A TRUCK MOUNTED PTD PUMP. THE STORAGE TANK OVERFLOWED AND DRIVER FAILED TO GET FUME SHUT DOWN IN TIME TO AVOID SPILLAGE INTO BEAMED AREA AROUND TANK(S). RELEASE LASTED FOR APPROXIMATELY 4 MINUTES. IT APPEARS THAT THE DRIVER WAS DISTRACTED DOING PAPERWORK AND WAS NOT IN ATTENDANCE AT THE DISCHARGE VALVES OF THE TRAILER. GARNER ENVIRONMENTAL SERVICE WAS CONTRACTED TO CLEAN-UP SPILL BY REMOVING AND REPLACING CONTAMINATED SOIL. TANKS WERE NOT MARKED TO INDICATE CAPACITY. TANK #2 WAS NOT MARKED TO INDICATE PRODUCT TYPE CORRECTLY. TANKS ARE NOT OUTFITTED WITH ANY TYPE OF OVERFILL PROTECTION DEVICE.

DRIVER WAS DISCIPLINED WITH DRY-OFFS, LOSS OF SAFETY BONUS, AND REMEDIAL TRAINING ON PROCEDURES OF UNLOADING WITH A PTO POWERED, TRUCK MOUNTED PUMP INTO ABOVE GROUND STORAGE TANKS. HE WAS ALSO REASSIGNED TO A TRUCK WITHOUT A PTO POWERED PUMP UNTIL REMEDIAL TRAINING COMPLETED.
