TRANSPORT VEHICLE DRIVER WAS ALERTED TO PRODUCT LEAKING FROM THE TRUCK, VEHICLE WAS PULLED TO SIDE OF HIGHWAY ON THE SHOULDER AND THE SULFURIC ACID WAS CONTAINED IN AN EARTHEN DITCH. MATERIAL WAS THEN NEUTRALIZED WITH LIME AND SOIL WAS EXCAVATED AND REMOVED TO APPROVED LANDFILL. THE PLASTIC FITTING AND VALVE ASSEMBLY ON THE TOTE TANK BROKE OFF INSIDE THE DISCHARGE NIPPLE AT THE BOTTOM OF THE TANK. CURRENT TESTING REQUIREMENTS PROVIDE FOR A PRESSURE TEST OF 29 PSI AND MOST LIKELY WOULD NOT HAVE IDENTIFIED THIS CONDITION. CONTINUED VISUAL INSPECTION WITH SPECIFIED TESTING WILL BE CONTINUED WITH ALL IBC TANKS.
