HOWEVER, HE FAILED TO COUPLE THE OTHER END OF THE HOSE TO THE CONSIGNEE'S PRODUCT STORAGE TANK INTAKE VALVE. CONSEQUENTLY, THE PRODUCT WAS ERRONEOUSLY DISCHARGED INTO THE STORAGE TANK'S CONTAINMENT AREA. ALL DISCHARGED LIQUED PRODUCT WAS CAPTURED AND CONTAINED IN THE STORAGE CONTAINMENT AREA.
