DRIVER WENT LEFT OF CENTER AND STRUCK ONCOMING VEHICLE THEN PROCEEDED OFF ROAD, STRUCK A POLE, AND OVERTURNED. DAMAGES TO THE TRACTOR AND TRAILER WERE EXTENSIVE. THE DRIVER RECEIVED INJURIES SO SEVERE (IMPACT, NOT HAZARDOUS MATERIAL), HE WAS PRONOUNCED DEAD AT THE SCENE BY THE CORONER. THE VEHICLE ONCE OVERTURNED IMPACTED A METAL CULVERT WHICH CAUSED EXTENSIVE DAMAGE TO THE CARGO TANK ALLOWING THE PRODUCT TO BE RELEASED. THE PRODUCT WAS SPILLED IN A FIELD AND A SMALL AMOUNT ENTERED THE TILE WHICH LEAD TO SUGAR CREEK. THE FIRE DEPARTMENT FOAMED THE AREA AND A SPILL CLEAN UP CONTRACTOR WAS CONTACTED TO ASSIST WITH REMEDIATION. THE HOME ON THE PROPERTY WHERE THE SPILL OCCURRED WAS EVACUATED AS A PRECAUTION DUE TO THE VAPORS. NATIONAL RESPONSE CENTER AND THE ILLINOIS EPA WAS NOTIFIED. THE INVESTIGATION CONTINUES IN REFERENCE TO THE ACCIDENT CAUSE. WITNESSES FOLLOWING OUR VEHICLE CONFIRMED HE HAD STOPPED AT A RAILROAD CROSSING JUST PREVIOUS TO THE ACCIDENT IT WAS HIS NORMAL SCHEDULE AND HE WAS IN COMPLIANCE WITH THE HOURS OF SERVICE REQUIREMENTS FATIGUE IS NOT BELIEVED TO BE AN ISSUE.
