ACCORDING TO THE INFORMATION OBTAINED THE FOLLOWING OCCURRED. WHILE TRAVELING ON I-74, WESTBOUND NEAR MILE MARKER 44 IN GALESBURG, ILLINOIS, THE DRIVER WAS INVOLVED IN A SINGLE VEHICLE ACCIDENT. APPROXIMATELY, FIVE HUNDRED AND FORTY-FIVE GALLONS OF FREE PRODUCT WERE RELEASED. THE ILLINOIS STATE POLICE AND THE COLONA FIRE DEPARTMENT RESPONDED TO THE SCENE. THE COLONA FIRE DEPARTMENT PLACED DOWN HI-FOAM ON THE TANKER. INTERSTATE 74, BOTH WESTBOUND AND EASTBOUND LANES GALESBURG, ILLINOIS, WERE CLOSED DOWN AS A RESULT OF THE ACCIDENT. ENVIRONMENTAL MANAGEMENT SERVICES, INC. RESPONDED TO THE PERFORM THE CLEANUP. ENVIRONMENTAL MANAGEMENT SERVICES, INC. USED TWO VACUUM TRUCKS TO TRANSFER THE PRODUCT INTO A RECOVERY TANKER. EXCAVATION OF THE CONTAMINATED SOIL WILL BE PERFORMED BY ENVIRONMENTAL MANAGEMENT SERVICES, INC. ALL FEDERAL, STATE AND LOCAL REGULATORY AUTHORITIES WERE CONTACTED.
