ACCORDING TO THE INFORMATION OBTAINED, THE FOLLOWING OCCURRED. WHILE TRAVELING, HIGGINS TRANSPORT WAS INVOLVED IN A VEHICLE ACCIDENT, CAUSING TRUCK TO ROLLOVER OFF ROAD SHOULDER, RESULTING IN THE RELEASE OF APPROXIMATELY 5,855 GALLONS OF DIESEL FUEL. FREE PRODUCT RELEASED TO A DRY DRAINAGE SWALE AND SOIL ADJACENT THE HIGHWAY. THERE WERE NO STATE WATERS AFFECTED OR THREATENED BY THE RELEASE. WAYNE'S TOWING RESPONDED TO RECOVER THE VEHICLE, AND ASSIST IN RESPONSE. SCIM, SUBSIDIARY OF WAYNE'S, PERFORMED THE CLEANUP. SCIM CONTINUED EXCAVATION ACTIVITY UNTIL ALL CONTAMINATION WAS RECOVERED. SCDHEC OVERSAW RESPONSE ACTIONS AND WAS SATISFIED WITH SCIM EFFORTS. DISPOSAL WAS COORDINATED IN ACCORDANCE WITH LOCAL, STATE, AND FEDERAL REGULATIONS. THERE WERE NO INJURIES OR EXPOSURES REPORTED.
