PRODUCT LEAKED OUT OF DOME AREA ON EACH COMPARTMENT. THE FIRE DEPARTMENT WAS NOTIFIED. THE RESPONSE TEAM SECURED THE AREA AND PUT BUCKET UNDER EACH COMPARTMENT. ANOTHER TRAILER WAS BROUGHT IN AND THE LOAD WAS TRANSFERRED ONTO IT. ONCE THE TRAILER WAS UP RIGHTED AND OUT OF THE WAY. CLEAN VENTURE REMOVED THE CONTAMINATED SOIL AND RAN SOIL SAMPLES. THE DRIVER HAS BEEN INSTRUCTED NOT DROP LOADED TRAILERS UNLESS ON CONCRETE PAD AT CUSTOMERS OR HIS TERMINAL.
