The Flying J Transportation (FJ) driver had moved over to the far left lane to allow for merging traffic to move into middle lane because the far right lane was an exit only lane. FJ driver started to move back into middle lane when he clipped the car that he was unable to see. This caused the car to spin out of control in front of the FJ truck. FJ driver tried to slow down and avoid hitting car when he lost control and went into median and rolled over.

Flying J has a safety committee review all accidents and it was determined by the committee that this was a major preventable accident. Because of this, the driver's employment with FJ was terminated. FJ requires drivers to go through intense new hire training as well as recurring monthly training afterwards. Each driver is trained in the Smith System Safe Driving System to help prevent accidents and change driving habits for the better. We will continue to enhance training programs and develop new programs to help prevent these types of incidents in the future.
