Describe:

The tractor trailer was involved in a head on collision with a pick up truck apparently going the wrong way on the freeway. The result was the tractor trailer over turning and leaving the roadway. The rear man way cover was buried into the ground. A transfer of material was performed in which 1000 gallons was not accounted for. When the truck was up righted, the rear man way cover wing nuts were sheared off. The material had entered the soil turning it into a sludge like material. The material was excavated and staged on site until approval could be obtained for disposal. The site was back filled with soil and lime per the request of TN DEC. It was then graded, seeded and straw was placed down to return it to its original state.
