DRIVER INITIALLY CONNECTED AIR SUPPLY FROM TRACTOR. PLANT OPERATOR THEN INSTRUCTED DRIVER TO USE PLANT AIR. DRIVER CONNECTED THE PLANT AIR AND ALLOWED TRAILER TO BUILD PRESSURE FOR 2-3 MIN. THE DRIVER THEN REALIZED THAT SHE DID NOT HAVE A 3 TO 2 REDUCER. DRIVER CALLED SHOP AND HAD ONE SENT. WHEN DRIVER PROCEEDED TO FINISH HOOKING-UP, DRIVER TURNED THE AIR SUPPLY BACK ON AND THEN WENT TO TAKE OFF DUST CAP ON THE 2 INCH DISCHARGE LINE. THE DUST CAP BLEW OFF AND PRODUCT STARTED COMING OUT OF THE DISCHARGE LINE DISPENSING 150 GALLONS OF 50% CAUSTIC ONTO DRIVER AND PLANT PROPERTY. THE EXTERNAL AND INTERNAL VALVES WERE WIDE OPEN PRIOR TO THE DUST CAP BEING REMOVED. PPE THAT DRIVER HAD ON WAS AS FOLLOWS: ACID JUMP SUIT, HARDHAT, CHEM. BOOTS, GLOVES AND SAFETY GLASSES. PPE REQUIRED FOR UNLOADING THIS PRODUCT: ACID SUIT, CHEM-GLOVES, FACE-SHIELD AND SAFETY GOGGLES, CHEM BOOTS. DRIVER DID NOT HAVE ON THE FACE-SHIELD & SAFETY GOGGLES.
