Describe:

Our employee arrived at the customer and was showed where to hook up and unload; customer signed off on Freight Bill and Bill of Lading. After about an hour and a half of unloading, driver was abruptly told to stop unloading due to storage overflow. Our employee was hooked up to a manifold that was in-turn hooked up to three storage tanks. It operated in such a fashion, that when one storage tank was full, it would move to one of the other two until all three were filled. The valve that controls this was not set properly causing the one storage tank to overflow. Customer fixed the problem and our driver continued to unload. Customer took full responsibility.
