ON 1/21/97, APPROXIMATELY 03:15, VEH #1 ARRIVED AT THE CONSIGNEE'S UNLOADING LOCATION. WHEN DRIVER REMOVED THE DUST CAP ON THE CARGO TANK'S UNLOADING VALVE, THE DRIVER FOUND THAT THE MOLTEN SULPHUR HAD LEAKED PAST THE WHEEL VALVE AND HAD COOLED, SETTING UP IN THE VALVE BONNET. THE DRIVER ATTEMPTED TO UNPLUG THE VALVE. WHEN THE MOLTEN SULPHUR IN THE TANK THAWED THE SULPHUR THAT WAS PLUGGING THE OUTLET ON THE VALVE OF THE CARGO TANK, THE PRODUCT STARTED TO SPILL OUT OF THE OUTLET. THE DRIVER ATTEMPTED TO REACH THE OUTLET VALVE HANDLE TO CUT OFF THE FLOW, HOWEVER, THE VALVE WAS NOT SEATED PROPERLY AND THE DRIVER WAS UNABLE TO CLOSE THE VALVE.
