CHAMBLEE, GEORGIA FIRE DEPARTMENT REPORTED THE STRONG ODOR OF DIESEL FUEL TO CARRIER PERSONNEL. INVESTIGATION REVEALED SOU 95034 HAD ROLLED FREE FROM WHERE THE CAR HAD BEEN SPOTTED FOR UNLOADING RESULTING IN THE BREAKAGE OF THE UNLOADING HOSE CONNECTED TO THE BOTTOM OUTLET VALVE. ALL CONTENTS OF THE CAR HAD ESCAPED BY THE TIME THE INCIDENT WAS DISCOVERED. CARRIER PERSONNEL, STATE AND FEDERAL ENVIRONMENTAL OFFICIALS AND PRIVATE CONTRACTOR EMPLOYEES IMMEDIATELY BEGAN EFFORTS TO CONTAIN AND CONTROL THE SPILL. REMEDIATION EFFORTS WERE SUCCESSFULLY COMPLETED ON 12-10-91. THE CAUSE OF THE INCIDENT REMAINS UNDER INVESTIGATION, HOWEVER, PRELIMINARY INDICATIONS ARE THE HANDBRAKE WAS RELEASED BY TRESPASSERS ALLOWING THE TANK CAR TO ROLL OVER A DERAILER DEVICE.
