THIS WAS NOT A PACKAGE FAILURE. THIS WAS AN AUTOMOBILE ACCIDENT. THE DRIVE HAD JUST PICKUP A LOAD OF DIESEL FUEL AT MAGELLAN TERMINAL 85 EAST ST NEW HAVEN CT 06511. HE THEN PROCEEDED TO RETURN BACK TO OFFICE AT 125 ATWATER ST PLANTSVILLE CT 06179. HE WAS TRAVELING ON I91N WHEN HIS FRONT TIRE BLEW OUT TRUCK WENT INTO GUARD RAILS, SPUN AROUND HIT BRIDGE PILLAR AND TANK BROKE OFF TRUCK. THE DIESEL FUEL CAME OUT ONTO HIGHWAY. RESPONSE FRO DOT, DEEP, STATE POLICE, LOCAL POLICE, FIRE AND AMBULANCE WAS ALMOST IMMEDIATELY. HIGHWAY CLOSED. DIESEL FUEL WAS BURNED OFF HIGHWAY. DOT PROCEEDED CLEAN UP. MCVAC ENVIRONMENTAL WAS CALLED INTO CLEAN UP.
