THE VEHICLE FAILED TO NEGOTIATE A CURVE IN THE TWO LANE COUNTRY ROAD AND RAN OFF THE TRAVELED PORTION OF THE ROAD TO THE RIGHT AS THE ROAD BEARED TO THE LEFT. THE VEHICLE ROLLED INITIALLY ONTO THE RIGHT SIDE ROLLING OVER AND COMING TO REST ON THE LEFT SIDE AFTER STRIKING A SMALL TREE AND A LARGE HIGHWAY BILLBOARD SIGN. SUPPORTS TO THE BILLBOARD SIGN PENETRATED THE OUTER SHELL OF THE TRAILER WHICH RESULTED IN THE LOSS OF VACUUM OF THE VESSEL CAUSING VENTING OF PRODUCT. APPROXIMATELY 2,000 GALLONS OF PRODUCT WAS MANUALLY VENTED TO ALLOW FOR UPRIGHTING THE VEHICLE.
