OUR TRACTOR-TRAILER WAS INVOLVED IN A ACCIDENT WHICH APPARENTLY CAUSED A FIRE. THE FIRE ENGULFED THE ENTIRE TRACTOR AND THEY BURNT THE FRONT PORTION OF THE TRAILER IT WAS PULLING. THE HIGH TEMPERATURE OF THIS FIRE CREATED A CRACK IN ONE OF THE COMPARTMENT'S INTERNAL VALVE AND THIS ALLOWED THE KEROSENE SPILLAGE. TERRA ENVIRONMENTAL CORPORATION WAS HIRED TO REMOVE THE 2900 GALLONS OF KEROSENE STILL INSIDE OUR TANKER AND TO EXCAVATE THE CONTAMINATED SOIL. THE CONTAMINATED SOIL WAS TRANSPORTED TO ORCHARD HILLS SANCTUARY LANDFILL FOR DISPOSAL.
