WHILE HANDLING TANK CAR GATX 15927, THE CSXT TRAIN CREW ASSIGNED TO H72315 OBSERVED LIQUID COMING FROM THE BOTTOM OF THE TANK CAR. THE AREA AROUND THE LEAKING CAR WAS IMMEDIATELY ISOLATED AND THE LOCAL FIRE DEPARTMENT WAS NOTIFIED. SEVERAL OTHER PARTIES WERE NOTIFIED AND RESPONDED TO ASSIST INCLUDING THE PRODUCT SHIPPER AND CSXT EMERGENCY RESPONSE CONTRACTORS. THE CXST CONTRACTOR PLACED A CONTAINMENT POOL UNDERNEATH THE LEAK TO HOLD THE RELEASED PRODUCT. THE PRODUCT WAS THEN TRANSFERRED TO TRUCKS FOR TRANSPORT BACK TO THE SHIPPER'S FACILITY. APPROXIMATELY 15657 GALLONS WERE RECOVERED IN THIS MANNER. A REMAINING BALANCE OF APPROXIMATELY 10,000 GALLONS WAS SPILLED ONTO THE GROUND. A PORTION OF THE MATERIAL RELEASED TO THE GROUND WAS RECOVERED BY DIGGING RECOVERY TRENCHES IN THE IMMEDIATE VICINITY OF THE TANK CAR AND RECOVERING THE LIQUID PRODUCT WAS VACUUM TRUCKS. A SIGNIFICANT AMOUNT OF SOIL AND BALLAST WAS EXCAVATED FOR DISPOSAL FROM THE SPILL AREA. UPON CLOSER INSPECTION OF THE TANK CAR IT WAS DETERMINED THAT THERE WAS A CRACK IN THE TANK SHELL. THE CRACK APPEARS TO HAVE ORIGINATED NEAR THE POINT WHERE THE BOTTOM OUTLET ASSEMBLY IS WELDED TO THE TANK SHELL. THE CRACK EXTENDED UP THE RIGHT AND LEFT SIDES OF THE TANK SHELL.
