Driver was driving on I-5 (Golden State Freeway) from SR-2 e/b (Glendale Freeway) at 30 miles per hour in the #2 lane. Driver heard an explosion coming from tire rupturing. Driver felt vehicle trailer to begin to swerve left & right. Driver attempted to maintain control of vehicle by holding steering wheel straight. Driver applied breaks just as driver was approaching the I-5 over-cross. Driver looked into right rear view mirror and observed trailer swerving to the right, towards asphalt shoulder. Driver related vehicle trailer tilted to the right and subsequently overturned onto its right side, colliding with the concrete roadway. Vehicle slid forward, on its right side, and slid under the I-5 overcross.
