### Describe:

XPO Logistics - LTU called to report a hazardous cargo release. It was reported poly tote of a Sodium Hydroxide Solution was punctured by a fork blade inside the trailer and was actively leaking. ERTS dispatched ERS of OK to conduct cleanup.

At 0615 ET, ERS personnel arrived onsite and confirmed approximately 100 gallons of product released to the trailer floor in a 50' x 8.5' area and another 100 gallons impacted a 140' x 100' area of the asphalt parking lot. The product remaining in the damaged tote was pumped out into a new one. The damaged tote was then cut up and containerized. Oil dri was deployed and worked into all impacted areas with power brooms. Once material was solidified and collected with absorbents, all impacted absorbents were collected and containerized into (10) 55 gallon poly drums. All waste was staged onsite for terminal personnel to manage.
