OUR VEHICLE WAS INVOLVED IN A MAJOR, 1 VEHICLE ACCIDENT WHICH INVOLVED A ROLLOVER OF OUR EQUIPMENT. THE DRIVER SAID THAT THE RIGHT SIDE TIRES GOT OFF, ON THE SOFT SHOULDER OF THE INTERSTATE. THE DRIVER SAID THAT HE TRIED TO GET IT BACK UP ON THE INTERSTATE AND OVERCORRECTED, CAUSING THE TRACTOR AND THE TRAILER TO ROLLOVER 1 ½ TIMES. THE TANKER WAS PUNCTURED IN SEVERAL DIFFERENT PLACES AFTER THE ROLLOVER, CAUSING THE SPILLAGE. EMERGENCY RESPONSE PHONE CALLS WERE MADE TO THE INDIANA STATE POLICE, INDIANA DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, WOLCOTT FIRE DEPARTMENT, DUKES EARTH SERVICES (SPILL RESPONSE) R & D TRANSPORT'S OPERATIONS MANAGER, DISPATCHER AND MAINTENANCE DEPARTMENT.
