Describe:

The tractor trailer went off road and become overturned. There were 12 totes of UN1791 damaged during the incident. 2 totes were severely damaged, releasing a combined 370 gallons of material very rapidly. The ten other totes were slightly damaged, releasing approximately 15 gallons each over the time of the response. The area was boomed, all visibly saturated soils hand excavated and contained, and all salvageable material pumped into a new tote (290 gallons salvaged from two severely damaged totes). Additionally, the slightly damaged totes were secured and taken offsite as well.
