An unsecured propane tank fell from the back of a service truck onto the roadway breaking off the service valve. Liquid propane escaped through the broken valve until the liquid level of the tank was below the valve. As the pressure dropped and only vapor was being released, a wooden spike was driven into the opening to stop the leak.
