APPROX 2210 TRAIN X57820 HAD ENGINE TROUBLE AND WAS STOPPED AT THE BOLOXI BRIDGE. WHILE THE TRAIN WAS STOPPED THE DRAW BRIDGE ATTENDANT NOTICED THAT TANK CAR GATX98249 WAS LEAKING FROM THE BOTTOM OUTLET VALVE. THE SHIPPER WAS NOTIFIED. THE LOCAL AUTHORITIES RESPONDED AND C.E.T ENVIRONMENTAL WAS ALSO DISPATCHED TO HANDLE THIS LEAKING TANK CAR AND THE CLEAN UP EFFORTS AS NEEDED. NOTE: THE FIRE DEPT. EVACUATED 40 PEOPLE FROM IMMEDIATE AREA AND ONE CSX EMPLOYEE WAS HOSPITALIZED OVERNIGHT FOR OBSERVATION. HE WAS RELEASED THE NEXT MORNING WITH NO FURTHER TREATMENT. BASICALLY THE LEAK WAS STOPPED WHEN C.E.T PERSONNEL TIGHTENED THE TOP OPERATIONS BOTTOM OUTLET VALVE.
