THE 5 GALLON CANS WERE PALLETIZED AND STRETCH WRAPPED WITH PLASTIC WRAP. WHEN THE CANS WERE DOWN LOADED AND UNPACKED, THE DAMAGED CAN WAS FOUND. THE LEAKING CAN WAS OVER PACKED INTO A METAL/CONTAINER. THE SPILL WAS CONTAINED TO THE CARDBOARD PAPER ON THE WOODEN PALLET.
