PRODUCT WAS REMOVED BY VACUUM TRUCK FOR FREE STANDING PRODUCT AND SOIL WAS REMOVED BY TRACHOE. CONTAMINATED PRODUCT WAS PLACED IN ROLLOFF BOXES FOR PROPER DISPOSAL. BACK FILL WAS USED TO COVER EVACUATED AREA. DISPOSAL IS STILL PENDING.
