Tank car GATX 219735 was involved in a derailment near Ellendale, MN on 11/11/2016. As a result of the derailment the car was punctured mid car left side. The puncture was approximately 4 inches long and 1/2 inch wide. The contents (propane) released for approximately 20 hours until a controlled vent and burn procedure emptied the car's contents.
