DRIVER WAS ATTEMPTING TO OFF LOAD PRODUCT WITH THE USE OF AIR PRESUURE. A SHORT TIME AFTER THE AIR PRESURE WAS APPLIED, IT WAS DISCOVERED THAT THE PRODUCT WAS NOT FLOWING INTO THE CUSTOMERS STORAGE TANK. WHILE TRYING TO DETERMINE THE REASON FOR THE PRODUCT NOT FLOWING, DRIVER NOTICED PRODUCT HAD BEGAN TO DRIP FROM THE CLAMP HOLDING THE EXTERNAL VALVE IN PLACE. WHEN HE ATTEMPTED TO TIGHTEN THE CALM, IT CAME APART ALLOWING THE EXTERNAL VALVE TO SEPARATE FROM THE TANK . THIS ALLOWED THE PRODUCT TO FLOW UNDER PRESSURE UNTIL ANOTHER DRIVER WHO HAD SEEN WHAT HAPPENED WAS ABLE TO CLOSE THE INTERNAL VALVE ONT HE TANK. ALTHOUGH DRIVER THAT WAS ATTEMPTING TO TIGHTEN THE CLAMP DID GET THE PRODUCT ON HIM, HE WAS ABLE TO WASH IT OFF IN AN EMERGENCY SHOWER BEFORE BEING INJURED AN ANY WAY. SPILLED PRODUCT WAS CONTAINED IN THE IMMEDIATE AREA AND NEUTRALIZED BY PLANT PERSONNEL. TOTAL CLEAN UP HAS NOT BEEN COMPLETED AS OF THIS DATE. BECAUSE THE CLEANUP HAD NOT BEEN COMPLETED, THE TOTAL COST FOR THE PRODUCT LOSS AND CLEANUP HAS NOT BEEN DETERMINED.
