USUAL PROCEDURE IS TO PUMP INTO A LARGE ABOVE GROUND STORAGE, BUT THE SUPERVISOR ON DUTY INSTRUCTED OUR DRIVER TO PUMP INTO THE UNDERGROUND STORAGE TANKS WHICH WOULD NOT HOLD THE ENTIRE LOAD OF PRODUCT CAUSING AN OVERFILL IN THE UNDERGROUND TANK. EPA WAS NOTIFIED IN AMARILLO, TX. AND EQUIPMENT AND MANPOWER WAS MOVED IN TO EFFECT CLEAN-UP.
