- A TANKER TRUCK OWNED BY ELLIS OIL COMPANY WAS OFF LOADING DIESEL FUEL AT THE MONTGOMERY CITY YARD WHEN THE BRAKES MALFUNCTIONED AND THE TRUCK ROLLED FORWARD, BREAKING THE SEAL BETWEEN THE TANK PIPING AND THE TRUCK'S DISPENSER. THE DRIVER SHUT OFF THE FLOW OF THE DIESEL FUEL FROM THE TANKER AFTER APPROXIMATELY 200 GALLONS OF DIESEL FUEL WAS RELEASED ONTO THE ASPHALT PARKING AREA.

- ELLIS OIL REPRESENTATIVES CONTACTED CDG ENGINEERS AND THE MONTGOMERY FIRE DEPT. THE MONTGOMERY FIRE DEPT USED ABSORBENT PADS TO SOAK UP THE DIESEL FUEL AND DAM THE SINGLE DRAIN LOCATED IN THE ASPHALT PARKING AREA. THE ALABAMA DEPT. OF ENVIRONMENTAL MANAGEMENT (ADEM) AND NRC WERE ALSO NOTIFIED. SAND WAS ALSO SPREAD OVER THE AFFECTED AREA. THE ASPHALT BEGAN TO ERODE IN THE AREA OF THE RELEASE. ON APRIL 10, 2012 CDG PERSONNEL REMOVED THE DEGRADED ASPHALT, WHICH WAS REPLACED WITH APPROXIMATELY 33 CUBIC YARDS OF CONCRETE.
