OPERATOR CAME BACK AND TOLD DRIVER TO BEGIN PUMPOFF. WHILE UNLOADING LAST COMPARTMENT ON TRUCK DRIVER NOTICED PRODUCT COMING OUT OF TANK VENT. HE IMMEDIATELY SHUT DOWN AND NOTIFIED PLANT OPERATOR. IMMEDIATE SPILL RESPONSE ACTION WAS TAKEN. APPROX 3-6 GALS SPLASHED OUT OF CONTAINMENT AREA. ALL THE REST WAS INSIDE OF THE CONTAINMENT AREA. THERE WERE NO INJURIES AND NO PERSONNEL WERE SPLASHED OR CONTAMINATED WITH PRODUCT.
