DRIVER WAS SOUTHBOUND ON IH-35 NORTH OF GEORGETOWN, TX WHEN ANOTHER MOTORISTS INDICATED A SUBSTANCE LEAKING FROM THE TRAILER. THE DRIVER PULLED ONTO THE SHOULDER AND FOUND A LIQUID LEAKING FROM THE RIGHT SIDE OF THE TRAILER. HE CALLED THE A.F. SAFETY DEPT TO REPORT THE INCIDENT AND CALLS WERE MADE TO THE GEORGETOWN P.D. AND F.D. AND WILLIAMSON COUTY SHERRIFF'S DEPT. A 1/4 MILE AREA WAS ISOLATED AND THE SPECIAL UNIT OF THE GEORGETOWN F.D. BEGAN THEIR PROCEDURES TO NEUTRALIZE THE SPILL. A CONTRACTOR FOR A.F. ARRIVED AND TOOK CONTROL OF THE CLEAN-UP UNTIL ALL EQUIPMENT WAS REMOVED FROM THE SCENE. THEY RETURNED THE FOLLOWING DAY TO COMPLETE THE CLEAN-UP OF THE AREA SURROUNDING THE SPILL SITE.
