TRACTOR-TRAILER TRAVELING WEST ON ROUTE 414. AS THE UNIT CAME OUT OF A CURVE THE LOAD SHIFTED CAUSING THE UNIT TO ROLL ON ITS RIGHT SIDE OVER THE GUARD RAIL. THE TRAILER WAS PUNCTURED ON THE RIGHT REAR SIDE RELEASING APPROXIMATELY 2,300 GALLONS OF TOLUENE. THE BRADFORD COUNTY EMERGENCY MANAGEMENT UNIT CONTACTED AN EMERGENCY RESPONSE CLEAN-UP TEAM TO RESPOND TO THE INCIDENT. MEMBERS OF THE PENNSYLVANIA D.E.R. WERE ON THE SCENE. CARRIER PERSONNEL RESPONDED TO THE SCENE TO ASSIST IN THE CLEAN-UP. MATERIAL REMAINING IN THE TRAILER WAS TRANSFERRED TO ANOTHER OF THE CARRIER'S TANK TRAILERS BY CARRIER PERSONNEL.
